### **GROUNDS FOR OBJECTION NO. 1:**

Declarant cites no basis for personal knowledge regarding National Grange proceedings during the summer of 2012. Nothing in the attached Exhibits 12 & 13 supports the averment that there were at that time formal "allegations" against McFarland regarding the Vista Grange settlement, or that Pompper was retained solely to investigate that issue.

# COURT'S RULING ON OBJECTION NO. 1:

### OBJECTION NO. 2:

"Upon Mrs. Stefenoni taking on the position as interim Master of the State Grange, one of her first acts was to stop the State Grange from paying Mr. McFarland's salary. Mr. Luttrell agreed with Mrs. Stefenoni's position and advocated for her receipt of the salary over Mr. McFarland during his suspension," (¶ 3, p. 2:19-22)

#### GROUNDS FOR OBJECTION NO. 2:

Declarant cites no basis for personal knowledge regarding California State Grange or National Grange proceedings during the summer of 2012. Nothing in the attached Exhibit 10 supports the averment that Ms. Stefenoni actually stopped the California State Grange from paying McFarland his salary and took the salary for herself, or that Luttrell upheld Stefenoni in doing so.
