New Study shows \$22 billion lost yearly to poles-related broadband expansion delays

Western Carolina University Professor Edward J. Lopez and noted pole attachment expert Patricia D. Kravtin released a new, national study on the economic benefits of bringing high-speed broadband connectivity more quickly to unserved homes and small businesses across the country – but only if provider access to utility poles is reformed.

The study emphasized that broadband deployment today is often inhibited or entirely stopped by problematic behavior of utility pole owners and accounts for nearly \$22 billion in economic gains lost each year. On the other hand, if pole access rules are reformed to accelerate broadband deployment, American households and small businesses could collectively reap up to \$314 billion in new economic gains.

Advocacy Playbook – Build Back Better Act

The Issue:

In November of this year, the House on mostly party lines passed the \$1.75 trillion Build Back Better Act which includes various Democratic social and climate policies to be paid for primarily through changes to tax enforcement and increases in certain rates. The most significant segments of the bill are \$555 billion addressed to climate change programs, \$400 billion for universal pre-k, \$200 billion to extend previously create Child Tax Credits, \$200 billion for 4 weeks of guaranteed paid leave for workers, \$165 billion on various healthcare programs, \$150 billion for home health care, and \$150 billion for affordable housing. To pay for these new spending outlays, the bill includes increased funding to the IRS to decrease tax evasion, tax increases on high earners (a new 5% rate on income above \$10 million and a new 3% surtax on income over \$25 million) and on large corporations (a new 15% tax on corporations with over \$1 billion profits and a 1% surcharge on stock buybacks). The Build Back Better Act is currently being considered in the Senate where Democratic Senators are debating changes to State and Local Tax Deductions, the size and scope of various social spending elements, and potential other options for revenue provisions such as taxes targeting billionaires or corporate tax changes.

Why it matters:

The sweeping scope of the Build Back Better Act means that likely every American, whether they live in rural or urban areas, would be affected by the passage of the bill in some way. Of particular concern to rural Americans, the bill does include some provisions explicitly addressed to agriculture such as new protections for farm workers, money allocated to immigration reform, and debt forgiveness for struggling small farmers. As well, the Biden administration has sought to sell the bill in rural America by emphasizing the number of rural Americans who would benefit from social spending programs such as the Child Tax Credit and new provisions to address rising pharmaceutical prices. As the Senate debates the Build Back Better Act it is also important to be aware that previous versions of the bill included changes to step-up in basis and capital gains taxes which were supported by Chairman of the Senate Finance Committee Ron Wyden (D-OR) which were vigorously opposed by the National Grange and other agriculture groups.

What you can do about it:

While the National Grange has not taken an official stance in support or opposition to the Build Back Better Act in its entirety, the Grange is actively tracking the bill and fighting to ensure provisions which would harm rural America are not included. If you or members of your Grange want to take action on any of the many elements of the bill, one useful action you can take is to reach out to your Senators (if you are not sure who that is, use this website: <https://www.house.gov/representatives/find-your-representative>). Whether you plan to call, send an email, or write a letter to your Senators, it is useful to include a story about how this bill will affect you, your family, and your community. Each call, email, and letter an office receives is tallied up and considered when your Senator is deciding whether or not to support a bill, and extra weight is given to those contacts which include personal stories.
